ELECTIONS ARE COMING



TOWNSHIP ELECTION—MARCH 10, 2015

ALL PRECINCTS VOTE AT LIVONIA TOWNHALL

ALL Livonia Residents vote in the Town Hall Building located at 11162 265th Ave. Directions from the stop light at Hwy 169 and County Rd 4: go East on County Rd 4 to County Rd 39 (1 1/2 miles). Go North (left) on County Rd 39 (1/2 mile) to 265th Ave. Go East (right) on 265th Ave to Town Hall entrance.

POLLS OPEN: Polls open at 10:00 am and close at 8:00 pm. Voters waiting in line at closing time are allowed to register/vote. Those who arrive after the closing hour are not allowed to vote.

VOTER ELIGIBILITY: To be eligible to vote, a person must be 18 years of age or older the day of the election, a US citizen, and have maintained residence in MN for 20 days preceding the election.

YOU NEED TO REGISTER IF: You have moved, changed your name, just became eligible to vote, or have not voted in the last four years. Voter registration applications are available at the Township or County Offices. You can register on Election Day with the proper identification and proof of residency. To save time at the poll, you can register now.


You can absentee vote from February 6, 2015 through March 9, 2015. The office will be open for absentee voting on Saturday, March 7, 2015, from 10:00 am to 12:00 noon if you will be absent on Election day, Contact the Town Hall for information.

REMINDERS

- **Annual Clean-Up Day** will be Saturday, **April 25, 2015**, 8:00 am to 12:00 noon. We will have more information available in the Elk River Star News and on our website.
- **Local Board of Appeal and Equalization** has been set for Monday, **April 27, 2015** at 6:00 pm at the Livonia Town Hall. The purpose of the Board is to listen to any Livonia Township land-owner considering themselves aggravated by their assessment and can appear to show cause of having such assessment corrected. Contact Livonia Town Hall if you have any questions.



- Per MN Statute 160.2715a1, it is unlawful to push or plow snow into or across any public road. When clearing snow from your driveways, snow must be directed onto your own property. Exercise caution in following or approaching plow trucks. Snowplows are not as maneuverable as smaller vehicles. If you know someone is plowing snow across the road, call the County Sheriffs office at 763-765-3500 or 911. Violators will be cited.
- The Township will not be responsible for **damage** to any **underground lawn sprinklers** located within the road right-of-way (33 feet from the center of the road). Residents will be responsible to protect such systems from damage or relocate the sprinkler heads within property lines.
- Any motor vehicle left on any roadway or ROW in the Township that **impedes** the performance of the Township **snowplow efforts** shall be dealt with under the provisions of Parking Ordinance.
- All Township roads will be limited to 5 ton axle weight when **road restrictions** are put in place by MNDOT. Truck operators are urged to call MNDOT 1-800-723-6543 for road postings.

Thank you for following these rules so that our plow drivers can keep our roads clear of snow and in good repair!
