Sugarbush Park Walk/Ski/Snowshoe Luminary Event set for February 13, 2016 from 6:00 pm to 8:00 pm

Grab your snowshoes, ski or winter walking gear and join us! Enjoy complimentary hot chocolate or cider around the Bon-fire and explore the beautiful Sugarbush Preserve trails with your family, friends and neighbors. The trails will be softly lit with luminaries.



Free event. Park rules apply, after-dark closure is waived for this event. Event will be held as long as conditions permit. Sugarbush Park is located at the end of the cul-de-sac on 232nd Ave just off of 239th Ave.



- The plows are called out when an accumulation of 3 inches or more has fallen, they are not sent out until snowfall has stopped or snowfall is more than 6 inches.
- The Township is not responsible for: Snow thrown in driveways, repair or replacement of mailboxes, fences, etc., damaged by thrown snow or equipment hitting the above objects that are not properly located or installed, or **damage to any type of landscaping done within the Right-of-Way** (Township Right-of-Way is 33 feet from the centerline of the road.)

- Per MN Statute 160.2715a1, it is unlawful to push or plow snow into or across any public road. When clearing snow from your driveways, snow must be directed onto your own property. Exercise caution in following or approaching plow trucks. Snowplows are not as maneuverable as smaller vehicles. If you know someone is plowing snow across the road, call the County Sheriffs office at 763-765-3500 or 911. Violators will be cited. Snow piles left on or near the side of the road create a hazard to all vehicles including plow equipment.



- Please do not place garbage receptacles in the road especially during a snowfall.
- **Annual Clean-Up Day** will be Saturday, **April 30, 2016**, 8:00 am to 12:00 noon. We will have more information available in the Elk River Star News and on our website.
- **Local Board of Appeal and Equalization** has been set for Monday, **April 25, 2016** at 6:00 pm at the Livonia Town Hall. The purpose of the Board is to listen to any Livonia Township landowner considering themselves aggravated by their assessment and can appear to show cause of having such assessment corrected. Contact Livonia Town Hall if you have any questions.
- The Township will not be responsible for damage to any underground lawn sprinklers located within the road right-of-way (33 feet from the center of the road). Residents will be responsible to protect such systems from damage or relocate the sprinkler heads within property lines.
- Any motor vehicle left on any roadway or ROW in the Township that impedes the performance of the Township snowplow efforts shall be dealt with under the provisions of Parking Ordinance.
- All Township roads will be limited to 5 ton axle weight when road restrictions are put in place by MNDOT. Truck operators are urged to call MNDOT 1-800-723-6543 for road postings.

Thank you for following these rules so that our plow drivers can keep our roads clear of snow and in good repair!

ALL PRECINCTS VOTE AT LIVONIA TOWNHALL

ALL Livonia Residents vote in the Town Hall Building located at 11162 265th Ave. Directions from the stop light at Hwy 169 and County Rd 4: go East on County Rd 4 to County Rd 39 (1 1/2 miles). Go North (left) on County Rd 39 (1/2 mile) to 265th Ave. Go East (right) on 265th Ave to Town Hall entrance.

POLLS OPEN: Polls open at 10:00 am and close at 8:00 pm. Voters waiting in line at closing time are allowed to register/vote. Those who arrive after the closing hour are not allowed to vote.

VOTER ELIGIBILITY: To be eligible to vote, a person must be 18 years of age or older the day of the election, a US citizen, and have maintained residence in MN for 20 days preceding the election.

YOU NEED TO REGISTER IF: You have moved, changed your name, just became eligible to vote, or have not voted in the last four years. Voter registration applications are available at the Township or County Offices. You can register on Election Day with the proper identification and proof of residency. To save time at the poll, you can register now.

You can absentee vote from February 5, 2016 through March 7, 2016. The office will be open for absentee voting on Saturday, March 5, 2016, from 10:00 am to 12:00 noon if you will be absent on Election day, Contact the Town Hall for information.

ABSENTEE VOTING: Please contact Sherburne County Auditor/Treasurer's Office at 763-765-4351 or 1-800-438-0576 for an application for absentee ballot.


