PRESIDENTIAL NOMINATING PRIMARY ELECTION

This election will take place on MARCH 3rd 2020

- **Precincts 1 & 3** please vote at Freshwaters Church  
12475 273rd Avenue near intersection of 273rd Ave & US HWY 169
- **Precinct 2** please vote at Livonia Townhall  
11162 265th Avenue near Cty Rd 4 & Cty Rd 39
- Polls open at 7:00 am and close at 8:00 pm
- Absentee Voting is done at Sherburne County Government Center



- The plows are called out when an accumulation of 3 inches or more has fallen, they are not sent out until snowfall has stopped or snowfall is more than 6 inches.
- The Township is not responsible for: Snow thrown in driveways, repair or replacement of mailboxes, fences, etc., damaged by thrown snow or equipment hitting the above objects that are not properly located or installed, or **damage to any type of landscaping done within the Right-of-Way** (Township Right-of-Way is 33 feet from the centerline of the road).

- Per MN Statute 160.2715a1, it is unlawful to push or plow snow into or across any public road. When clearing snow from your driveways, snow must be directed onto your own property. Exercise caution in following or approaching plow trucks. Snowplows are not as maneuverable as smaller vehicles. If you know someone is plowing snow across the road, call the County Sheriff's department at 763-765-3500 or 911. Violators will be cited. Snow piles left on or near the side of the road create a hazard to all vehicles including plow equipment.



- **Please do not place garbage receptacles in the road especially during a snowfall.**
- The Township will not be responsible for damage to any underground lawn sprinklers located within the road right-of-way (33 feet from the center of the road). Residents will be responsible to protect such systems from damage or relocate the sprinkler heads within property lines.
- Any motor vehicle left on any roadway or ROW in the Township that impedes the performance of the Township snowplow efforts shall be dealt with under the provisions of Parking Ordinance.
- All Township roads will be limited to 5 ton axle weight when road restrictions are put in place by MNDOT. Truck operators are urged to call MNDOT 1-800-723-6543 for road postings.

Thank you for following these rules so that our plow drivers can keep our roads clear of snow and in good repair!

- **Annual Clean-Up Day** will be Saturday, **May 2nd, 2020**, 8:00 am to 12:00 noon. We will have more information available in the Elk River Star News and on our website.
- **Local Board of Appeal and Equalization** has been set for Monday, **April 27th, 2020** at 6:00 pm at the Livonia Town Hall. If you disagree with the valuation or classification after discussing it with your assessor, you may appear before the local Board of Appeal and Equalization. The board will review your assessments and may make corrections as needed. Contact Livonia Town Hall if you have any questions.

## ALL PRECINCTS VOTE AT LIVONIA TOWNHALL FOR TOWNSHIP ELECTION ON MARCH 10, 2020 ALL OTHER ELECTIONS PLEASE VOTE AT DESIGNATED PRECINCT LOCATIONS

ALL Livonia Residents vote in the Town Hall Building located at 11162 265th Ave. Directions from the stop light at Hwy 169 and County Rd 4: go East on County Rd 4 to County Rd 39 (1 1/2 miles). Go North (left) on County Rd 39 (1/2 mile) to 265th Ave. Go East (right) on 265th Ave to Town Hall entrance.

**POLLS OPEN: Polls open at 10:00 am and close at 8:00 pm.** Voters waiting in line at closing time are allowed to register/vote. Those who arrive after the closing hour are not allowed to vote.

**VOTER ELIGIBILITY:** To be eligible to vote, a person must be 18 years of age or older the day of the election, a US citizen, and have maintained residence in MN for 20 days preceding the election.

**YOU NEED TO REGISTER IF:** You have moved, changed your name, just became eligible to vote, or have not voted in the last four years. Voter registration applications are available at the Township or County Offices. You can register on Election Day with the proper identification and proof of residency. To save time at the poll, you can register now.

**You can absentee vote from February 7, 2020 through March 9, 2020. The office will be open for absentee voting on Saturday, March 7, 2020, from 10:00 am to 12:00 noon if you will be absent on Election day, Contact the Town Hall for information.**
